ITEM 5 - RATIFICATION OF EMAIL DECISIONS

5.1 2025 QLD Women's and Girls Championship

6.1 CAQ Approval of Tournaments Before FIDE Registration

This was a previous motion moved by the 2024 CAQ Council.

Previous Motion: That all future events held in Qld which are FIDE Rated be approved by CAQ Council before being registered for FIDE rating.

This is not supported by Bill Gletsos. This cannot and will not be enforced.

6.2 Inclusion of FMs in Reimbursement of Entry Fees

7 January 2024 Motion: That the CAQ reimburses the entry fees of Grandmasters, Women Grandmasters, International Masters, Women International Masters and Fide Masters (rated over 2200 ACF or FIDE on the current rating list) to CAQ Inc affiliated Clubs or approved Individual Organizers for any CAQ approved classically rated Open Chess Tournaments held in Queensland in 2024.

Leave this as it is for now.

6.3 Recommendations from AGM

Motion 8.1: That this 2024 CAQ Inc AGM recommends to the 2025 CAQ Inc COUNCIL that it supports CAQ Inc Affiliated Clubs and approved Individual Organisers with a \$500 subsidy to run regional weekend classically rated Open Chess Tournaments OR with a \$300 subsidy to run weekend classically rated Open Chess Tournaments in South-East Queensland.

That this subsidy be paid once the Tournament Entry Form is placed on the CAQ Inc Website and an application is then made to the CAQ Inc Treasurer.

For the purposes of this motion, Redcliffe, Brisbane, Logan, Ipswich and Gold Coast will be considered South-East Queensland Events and be entitled to a \$300 CAQ Inc subsidy and all other CAQ Inc approved Open Weekend Chess Tournaments be considered Regional events and be entitled to a \$500 CAQ Inc subsidy.

It is also noted that no CAQ Inc affiliated Club or approved Individual Tournament Organiser can claim no more than three CAQ tournament subsidies between January 1 2025 and December 31 2025.

Motion: That we ratify 8.1 Motion from the AGM with the alteration of no more than 3 subsidies per year.

Motion 8.2: That this 2024 CAQ Inc AGM recommends to the 2025 CAQ Inc Council that it subsidise the CAQ Inc affiliated Club Or approved Individual Organiser that organises and runs the 2025 CAQ Inc Queensland Open with an extra \$500 subsidy, on top of any other subsidy they are entitled to, and that this subsidy be paid once the 2025 Queensland Open entry form is placed on the CAQ Inc Website and application is then made to the CAQ Inc Treasurer.

6.4 Ban from FNQ Inter-School Events

6.5 Reduction in Fees for QLD Women's and Girls Championship

Motion: That the 2025 CAQ Inc Council clearly demonstrate its complete support of the FIDE, ACF and QJ rated QUEENSLAND WOMEN'S AND GIRLS' CHESS CHAMPIONSHIP 2025 Under 18 Division on Saturday April 12 and Sunday April 13 by reducing the entry fee from the current \$100 fee to a \$75 entry fee and the \$40 to \$35 and that the CAQ Inc cover any financial loss this tournament may make.

Such payment is without admission and without prejudice and pleaded in any court or tribunal in relation to any issues raised in correspondence dated 7/11/2024, 12/11/2024, 26/11/2024, 15/1/2025, 2/2/2025, 17/2/2025, 18/3/2025 and 24/3/2025.

a great supporter of the CAQ. Perhaps we should offer condolences to the wang family.
