#### 6.1 Position of Secretary and Publicity Officer

## 6.3 CAQ donation to the Olympiad Appeal

## 6.4 Hosting the ASTC – Cairns 2022

Hughston Parle presented a verbal report highlighting that the tournament was on track, and that the website would be released over the next two months. Discussion pertaining to the possibilities of transporting DGT boards to Cairns. Discussion was also had on the possibilities of hosting a tournament simultaneously.

#### 6.5 Queensland JETS Part 2 – 2022

Decided that the 2022 QJETS would go ahead in the Term 3 and Term 4 school holiday breaks respectively.

## 6.6 Training for DGT Boards

The council discussed proposals to provide training for Queenslanders for DGT boards

## 6.7 Access and use of CAQ Membership Lists

The council discussed the relevant CAQ Councilors that had access to CAQ Membership list. Mechanisms to import this list to a dropbox were discussed.

#### 6.8 Publicity of CAQ Events

As Shaun Curtis set this item on the meeting agenda, but was an apology for the meeting and was thus unable to present his policy.

#### 6.9 Arbiters at CAQ Events

The Council discussed the adoption of FIDE Arbiters Manual Article 12 for the role of the Arbiter. Douglas Williams and Andrew Fitzpatrick were to draft by-law changes accommodating the following:

- All arbiters must become registered NAs.
- That the FIDE Arbiters Mannual Article 12 be adopted for the role of arbiter.
- 1 per 50 required, 1 per 40 for FIDE, with 1 per 30 recommended.

#### 6.10 Unapproved Withdrawals

The council discussed policies and consequences for unapproved withdrawals from tournaments yet no consensus was reached.

#### 6.11 Affiliation of King & Queen Junior Club;

The council rejected the affiliation of the King and Queen Junior Chess Club.

## 6.12 CAQ Fees for Rapid and Blitz tournaments;

The CAQ amended the fees for Rapid and Blitz tournaments as follows:

**Motion:** "That the CAQ fees for ACF Quick Rating be 50 cents per player per game, capped at a maximum of \$2.50 per player per tournament as of July 1."
