"That the Australian Chess Federation calls on the FIDE Ratings Officer to retract comments #116 and #118 on the thread titled "2022 GOLD COAST OPEN 23-27 JUNE INCORPORATING AUSTRALIAN CHAMPION TITLE". The Australian Chess Federation also calls on the FIDE Ratings Officer to make a public apology in the same thread for any hurt, embarrassment or adverse inference caused to the Chief Organisers and Chief Arbiter of the Gold Coast Open.""
