8.1 That this 2024 CAQ Inc AGM recommends to the 2025 CAQ Inc COUNCIL that it supports CAQ Inc Affiliated Clubs and approved Individual Organisers with a \$500 subsidy to run regional weekend classically rated Open Chess Tournaments OR with a \$300 subsidy to run weekend classically rated Open Chess Tournaments in South-East Queensland.

That this subsidy be paid once the Tournament Entry Form is placed on the CAQ Inc Website and an application is then made to the CAQ Inc Treasurer.

For the purposes of this motion, Redcliffe, Brisbane, Logan, Ipswich and Gold Coast will be considered South-East Queensland Events and be entitled to a \$300 CAQ Inc subsidy and all other CAQ Inc approved Open Weekend Chess Tournaments be considered Regional events and be entitled to a \$500 CAQ Inc subsidy.

It is also noted that no CAQ Inc affiliated Club or approved Individual Tournament Organiser can claim more than two CAQ tournament subsidies between January 1 2025 and December 31 2025.

That this subsidy be paid once the Tournament Entry Form is placed on the CAQ Inc Website and an application is then made to the CAQ Inc Treasurer.

For the purposes of this motion, Redcliffe, Brisbane, Logan, Ipswich and Gold Coast will be considered South-East Queensland Events and be entitled to a \$300 CAQ Inc subsidy and all other CAQ Inc approved Open Weekend Chess Tournaments be considered Regional events and be entitled to a \$500 CAQ Inc subsidy.

It is also noted that no CAQ Inc affiliated Club or approved Individual Tournament Organiser can claim more than two CAQ tournament subsidies between January 1 2025 and December 31 2025.
